Master of Ceremonies

Rob Reed Executive Deputy Attorney General Commonwealth of Pennsylvania

Rob has been a career public servant working for 40 years in federal and state governments. Rob has served as an Assistant United States Attorney with the U.S. Attorney's Offices in Washington D.C. (1982-1987) and more recently in the (Eastern District of

Pennsylvania (EDPA) (1989-2017). As a federal prosecutor, Rob investigated, prosecuted, and supervised a wide range of cases from Civil Rights, to Violent Crime, to gang violence, to white collar crime and corruption. In 2010, Rob was named the Executive Assistant U.S. Attorney and was responsible for expanding the office's vision of criminal justice for the first time from solely relying on prosecution to include violence prevention, prisoner reentry and community outreach, including working with underserved communities. Rob was instrumental in supporting the trauma-informed care training of criminal justice professionals within the Philadelphia Police Department, in the EDPA and the DOJ. Rob also helped expand the USAO's nationally recognized Prisoner Reentry Program.

In March, 2017, Rob was appointed as an Executive Deputy Attorney General in the Pennsylvania Attorney General's Office and now oversees the Special Initiatives section. Rob speaks across Pennsylvania on a variety of subjects including, civil rights, violence prevention, prisoner reentry, school safety, addiction and the opioid epidemic, and trauma. In 2017, he spearheaded the creation of the Pennsylvania Reentry Council, which he chairs, that for the first time, brings together reentry stakeholders around the Commonwealth. Beginning in 2017, Rob also initiated an effort to make Pennsylvania a trauma-informed state. In 2020, Rob was selected to work with Governor Tom Wolf's Office of Advocacy and Reform (OAR) to create a Trauma-Informed Pennsylvania. In July 2020, OAR issued a report that establishes the foundations to create a trauma-informed Pennsylvania. 1 In the fall of 2020, the initiative was re-named HEAL PA and Rob was appointed to co-chair the HEAL PA Criminal Justice Action Team to enhance criminal justice outcomes and to create a trauma-informed criminal justice system. In 2022, Rob was elected to be a member of the HEAL PA Board of Directors. Recently, Rob was appointed as an Assistant Adjunct Professor in the Temple University Medical School.

Rob has a B.A. from the University of Pennsylvania, a M.Sc. from the London School of Economics, and a J.D. from Boston College Law School and is married with three children.







Honoree and Keynote Speaker

Jacqueline Maguire Special Agent in Charge FBI Philadelphia Field Office

Ms. Maguire was assigned to the New York Field Office when she joined the FBI as a special agent in 2000 and was a member of the Joint Terrorism Task Force. She was the lead agent for the investigation of the five hijackers of American Airlines Flight 77 after the 9/11 terror attacks.

In 2006, Ms. Maguire was promoted to supervisory special agent, and then to unit chief, in the Counterterrorism Division at FBI Headquarters in Washington. She moved to the Washington Field Office in 2011 as a supervisory special agent. She returned to FBI Headquarters in 2014 when she was named the special assistant to the executive assistant director of the Human Resources Branch.

Ms. Maguire was promoted in 2016 to assistant special agent in charge of the Birmingham Field Office in Alabama, where she oversaw all criminal and administrative matters. She was named section chief in the Office of Public Affairs at FBI Headquarters in 2017 and promoted to deputy assistant director in 2018. She was promoted in 2019 to special agent in charge of the Criminal Division of the New York Field Office. In 2021, she was selected as special agent in charge of the Philadelphia Field Office.

Ms. Maguire has earned several awards during her FBI career, including the 2006 Attorney General's Award for Excellence in Furthering the Interests of U.S. National Security and the 2009 Attorney General's Award for Distinguished Service.

Prior to joining the FBI, Ms. Maguire worked at the Office of the Medical Examiner in Suffolk County, New York. She earned a bachelor's degree in comprehensive science from Villanova University; a master's degree in criminal justice from Long Island University; and a master's degree in homeland defense and security from the Naval Postgraduate School.







Randy Duque

Deputy Director at Community Relations Division City of Philadelphia

Randy Duque is the Deputy Director in charge of the Community Relations Division of the Philadelphia Commission on Human Relations. He also served as the Acting Executive Director between 2020-2021 in which he was the first Asian American to lead the City agency. His responsibilities cover a wide range of areas including civil rights; immigrant and refugee issues; victim services; anti-violence initiatives; community-police relations; conflict intervention; hate incident tracking and response; and issues relating to changing neighborhoods. He also chairs an interagency civil rights taskforce that brings local organizations and governmental agencies together to discuss civil rights trends and issues that are affecting the local community. In addition, Randy has led the effort to create and chair the Philadelphia Civil Rights Rapid Response Team- an interdisciplinary group of civil rights focused individuals from city, state, and federal agencies, the school district, and advocacy groups—that focus on responding to hate crime and bias incidents; as well as, to educate stakeholders about various related topics. Through Randy's work and leadership, PCHR was presented the 2016 FBI Director's Community Leadership Award. In 2018 he received the PA Governor's Advisory Commission on Asian Pacific American Affairs (PA GACAPAA) "Outstanding Asian Americans and Pacific Islanders" recognition; and was bestowed a knighthood by the Knights of Rizal - a prestigious organization officially recognized by the Philippine government. Prominent members include the presidents in the Philippines' history and foreign recipients including King Juan Carlos I of Spain and Henry Kissinger. From 2019-2022, he served as a Commissioner on the GACAPAA and chaired the Commission's Civil Rights Taskforce.

Randy is an expert in conflict management who has mediated cases in family and neighborhood disputes, workplace issues, intergroup conflicts, and international military affairs. He has designed and conducts trainings locally, nationally, and internationally on a multitude of conflict subject matters including mediation, conflict resolution, restorative justice, critical incident response and de-escalation; intractable conflict; implicit bias and cultural competency; and conflict coaching. He has also guest lectured at various universities and colleges nationally and internationally and was also an adjunct instructor for the Psychological Studies in Education Program at Temple University.

Randy's education and experience covers a full spectrum of conflict theory and practice. He received his master's degree in communication and conflict; and bachelor's degree in Anthropology at Temple University (where he was also an adjunct instructor). He is a skilled martial arts practitioner and instructor; and served ten years in the infantry with the Pennsylvania Army National Guard.

In his spare time, Randy plays bass and guitar for several bands in different genres of music including a Filipino folk ensemble.







Abby Stamelman Hocky Executive Director Interfaith Philadelphia

Abby Stamelman Hocky has served as Executive Director of Interfaith Philadelphia since its inception in January 2004. She has a special interest in collaborative models of social change, and in the role of faith and culture in strengthening society.

Abby came to Interfaith Philadelphia after working in intergroup relations and public policy for over two decades at the Jewish Community Relations Council of Greater Philadelphia. Her work as Associate Executive Director and Director of Interreligious Relations entailed striving to enhance interfaith understanding, resolve issues among religious groups, and develop numerous models for dialogue – especially among Muslims, Christians and Jews.

Abby was appointed by Mayor Michael Nutter to serve on the Police Oversight Board (2015-16). She served as a Technical Advisor to non-profits in the West Philadelphia Economic Recovery Coalition program and serves as a member of NewCORE, (the New Conversation on Race and Ethnicity). She participated in the FBI Citizens Academy training and is a recipient of PCHR's Professional in Human Relations Award.

Abby received her BA from Lafayette College and her MSW from Yeshiva University's Wurzweiler School of Social Work.







Danielle M. Outlaw Police Commissioner City of Philadelphia

Philadelphia Police Commissioner, Danielle M. Outlaw, is an experienced and respected law enforcement leader. She stands at the helm of the nation's 4th largest police department, which employs more than 6500 sworn officers and 800 civilians who work to help make Philadelphia a safer city. Commissioner Outlaw is the first African-American woman to lead the Philadelphia Police Department.

A believer in the power of connectivity and continued learning, she meets people where they are, engages critics and contributes nationally and internationally to ensure the Department's narratives are accurately told, and to benchmark against other organizations to ensure best practices in contemporary policing here. Her overarching community safety goals are rooted in crime prevention and reduction, organizational excellence and community engagement and inclusion.

Commissioner Outlaw's TEDx Talk – Humanity In Authority – dispels the belief that the two concepts are contrary in nature and explains how the two concepts can, and should, co-exist. She has also presented on various topics including Race and Policing, Women in Law Enforcement, De-escalation and Investigation of Use of Force, Building Community Relationships after Controversy, and Video Recording in Policing and Early Intervention Systems. She has been asked to provide technical assistance in areas of police accountability and risk management.

Prior to taking the helm as Philadelphia's top law enforcement officer, Outlaw was the Chief of Portland, Oregon's Bureau of Police. She was the first African American woman to hold that post. Commissioner Outlaw began her law enforcement career in Oakland, California where she spent 20 years in service with the Oakland Police Department.

The Oakland, CA native has received numerous awards, including the Police Executive Research Forum (PERF) Gary P. Hayes Award, the Cascadia Behavioral Healthcare Culture of Caring Award for Community Relations and Civic Engagement, and has been honored as a 2019 Marie Lamfrom Woman of Distinction by the Girl Scouts of Oregon and Southwest Washington.

Commissioner Outlaw earned a Bachelor of Arts in Sociology from the University of San Francisco and a Master of Business Administration from Pepperdine University. She is also a graduate of the Police Executive Research Forum Senior Management Institute of Police, the Major Cities Chiefs' Association Police Executive Leadership Institute and the FBI National Executive Institute.

Commissioner Outlaw is a member of the International Association of Chiefs of Police Human and Civil Rights Committee, the National Organization of Black Law Executives and is an Eastern Region Representative member of the Major Cities Chiefs' Association. She continues to demonstrate her civic advocacy through Alpha Kappa Alpha Sorority, Incorporated and The Links, Incorporated.







Robert Warner Director Cure Violence Philadelphia

Robert Warner is the Director of Cure Violence Philadelphia; The program is housed at Temple University. He has been working with this program since 2013. This program is operational in schools, the streets, and in hospitals. They target high-risk individuals that may be involved in street activity. They mentor these young adults and help them become productive citizens.

Robert also graduated from the S.T.A.R. program, which helps ex-offenders when they come home from prison. He has spoken in many different places and with very important people all around the world. He had the privilege to sit down with President Barak Obama in 2016.

Robert has been with his wife for 34 years and looks forward to many more beautiful years. He has 1 daughter and 2 grandkids that he adores. He is eager to continue to help others and make our communities a safer place.
